

ORDINANCE NO. 2018.1

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF NORTH ENGLISH, IOWA, BY ADDING A NEW SUBSECTION REGARDING STOP REQUIRED.

BE IT ENACTED by the City Council of the City of North English, Iowa:

SECTION 1. NEW SUB-SECTION. The Code of Ordinances of the City of North English, Iowa, is amended by adding a new Sub-Section to Section 65.02 STOP REQUIRED, adding Sub-Section 12. North Street, which is hereby adopted to read as follows:

65.02 STOP REQUIRED. Every driver of a vehicle shall stop in accordance with the following:

1. Maple Lane. Vehicles traveling on Maple Lane shall stop at L Avenue.
2. Redwood Avenue. Vehicles traveling on Redwood Avenue shall stop at Woodland Drive.
3. Redwood Avenue. Vehicles traveling on Redwood Avenue shall stop at Main Street.
4. Woodland Drive. Vehicles traveling south on Woodland Drive shall stop at Woodbine Drive.
5. Railroad Street. Vehicles traveling west on Railroad Street shall stop at Main Street.
6. Oak Street. Vehicles traveling west on Oak Street shall stop at Highland Street.
7. Oak Street. Vehicles traveling west on Oak Street shall stop at West Street.
8. East Street. Vehicles traveling on East Street shall stop at Oak Street.
9. Cottonwood Street. Vehicles traveling on Cottonwood Street shall stop at Oak Street.
10. Woodbine Drive. Vehicles traveling west on Woodbine Drive shall stop at Woodland Drive.
11. Woodland Drive. Vehicles traveling north on Woodland Drive shall stop at Woodbine Drive.


12. North Street. Vehicles traveling south on North Street shall stop at Maple Lane.

SECTION 2. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 3. SEVERABILITY CLAUSE. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

SECTION 4. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval, and publication as provided by law.
