

CHAPTER 77

Golf Carts

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF NORTH ENGLISH, IOWA, 2017  
BY CHANGING GOLF CART OPERATION ON CITY STREETS:

BE IT ENACTED by the City Council, City of North English, Iowa:

SECTION MODIFIED, CHAPTER 77 MODIFIED, GOLF CARTS of the Iowa Code of Ordinances of the City of  
North English, Iowa 2017 is amended and the following adopted in lieu thereof:

CHAPTER 77 The Code of Ordinances of the City of North English, Iowa, 2017 is amending

SECTION 77.04 - ~~MANNER OF OPERATION~~ within CHAPTER 77, and

SECTION 77.07 – HOURS OF OPERATION within CHAPTER 77

which are hereby adopted to read as follows:

**SECTION 77.04 GOLF CARTS (4) MANNER OF OPERATION**

No persons under the age of eighteen (18) are permitted to operate a golf cart on city streets or alleys within the city limits. Persons possessing a valid driver's license and over the age of eighteen (18), are permitted to operate a golf cart on city streets within city limits, but must comply with all sections of this ordinance. *Persons between the ages of 14 and 18, possessing a valid driver's license, are permitted to operate a golf cart on city streets within the city limits, provided that they have taken and passed an ATV Education Course, as approved by the Iowa Department of Natural Resources. Person's between the ages of 14 and 18 must have an Education Certificate in his/her possession, indicating completion of the ATV Education Course, when operating a golf cart on city streets within the city limits.*

**SECTION 77.07 HOURS OF OPERATION**

Golf carts permitted to operate on streets only from sunrise to sunset each day.



ALL-TERRAIN VEHICLES AND SNOWMOBILES

CHAPTER 75 MODIFIED, ATV'S AND SNOWMOBILES of the Code of Ordinances of the City of North  
English, Iowa 2017 is amended and the following adopted in lieu thereof:


CHAPTER 75 The Code of Ordinances of the City of North English, Iowa, 2017 is amending

SUBSECTION 1 OF SECTION 75.06 OPERATION LIMITATIONS within CHAPTER 75, ALL-TERRAIN VEHICLES  
AND SNOWMOBILES, which is hereby adopted to read as follows:

**SECTION 75.06.1 OPERATION LIMITATIONS**

~~No persons under the age of eighteen (18) are permitted to operate an ATV on city streets or  
alleys within the city limits.~~ Persons possessing a valid driver's license and over the age of eighteen (18),  
are permitted to operate an ATV or Snowmobile on city streets within city limits, but must comply with  
all sections of this ordinance. ***Persons between the ages of 14 and 18, possessing a valid driver's  
license, are permitted to operate an ATV or Snowmobile on city streets within the city limits, provided  
that they have taken and passed an ATV Education Course, as approved by the Iowa Department of  
Natural Resources. Person's between the ages of 14 and 18 must have an Education Certificate in  
his/her possession, indicating completion of the ATV Education Course, when operating an ATV or  
Snowmobile on city streets within the city limits.***


